- **B.** Empowerment Grant and Sort -Sasha Haehn announced that the Empowerment Grant and Sort neighborhood recommendations will be presented to the City Council on October 8 and pending final HUD approval, the Empowerment projects will be funded and awarded in January 2020.

- **A. CAC community Appreciation Event** Topeka Zoo on September 28, 2019. Total of 4,396 guests. James Prout thanked all of the CAC and NIA members that volunteered. James stated that there was an incident at the event involving a volunteer using profanity towards a guest. He reminded everyone about the importance of appropriate behavior of CAC volunteers and the impact on public perception about the CAC and NIA organizations.
- **B.** NIA Recognition Event Vote- 8 to 3 voted to table until next year.

# C. CAC Community Visioning & Topeka Community Asset Mapping

LaToya Burnett-Martinez led the CAC in voting for a new draft CAC Vision Statement and 2020 Work Plan Goals. The outcome was as follows:

<u>Draft Citizen Advisory Council Vision</u> - selected by a majority of six (6) members was number 1: "Through community involvement stakeholders will build a safer, healthier, and prideful community."

<u>2020 Community Work Plan Goals</u> – listed below in order of priority by number of votes:

- 2. 5 votes for Crime Drugs, human trafficking/prostitution, person to person robbery/assault
- 5. 4 votes for Housing Vacant properties, homelessness, housing/property violations
- 3. 1 vote for Community Engagement lack of community pride/engagement, facilities, resources
- 4. 1 vote for Health Drug addiction, mental health, other medical conditions, food security and safety, childhood obesity
- 1. 0 votes for Sanitation cleanliness of neighborhood, street maintenance, and property maintenance
- 6. 0 votes for Zoning & Development high/low commercial development, housing development and zoning requirements
- 7. 0 votes for Youth lack of youth activities, youth safety concerns, and delinquent behaviors

Motion to adjourn was made by Susan McClacherty, seconded by Elinor Cowell. The motion carried and the meeting was adjourned at 7:34 PM.
