

**Call to Order.** Chair Roberts called the meeting to order at 5:31 pm.

**Roll Call.** Present: Chair Carol Roberts; Vice Chair Carmen Romero-Nichols; Commissioner Luc Bensimon (By Zoom); Commissioner Cynthia Hopp; Commissioner Pamela James (By Zoom); Commissioner Marisol Marcelo; Commissioner Sean McGimpsey; Commissioner Alexis Simmons (By Zoom); and Commissioner Zachary Surritt.

**Guests**. Ernestor De La Rosa, Chief Diversity Equity and Inclusion Officer; Zaynah Afada, Diversity Equity and Inclusion Program Coordinator; Mary Kuckelman, Senior City Attorney; and Kaitlyn Willis, Executive Assistant to the City Manager.

**Welcome and Introductions.** The Commission made introductions and welcomed new Commissioner, Marisol Marcelo.

**Adoption of April 24, 2023 Minutes**. Commissioner McGimpsey moved and Commissioner Surritt seconded a motion to adopt the minutes as written. Motion passed unanimously.

**Adoption of June 12, 2023 Agenda.** Vice Chair Romero-Nichols moved and Commissioner McGimpsey seconded a motion to adopt the agenda as written. Motion passed unanimously.

#### Old Business.

- **Update on Code Language/Bylaws.** Ernestor De La Rosa shared that he has reviewed the language and no major changes need to be made. The only section that may be removed is Section 2(e), which currently states that one of the duties of the commission is the review quarterly reports from the Independent Police Auditor and report any concerns to the City Manager. The consensus of the commission is to hold off on proposing any changes for the time being.
- Welcoming Week. Ernestor De La Rosa discussed initiatives below.
  - Taste of Topeka Festival. This event will take place in Evergy Plaza on Sunday, September 17. Ernestor reviewed the preliminary budget for this event and the Commission discussed potential sponsors.
  - **Videos.** Ernestor shared that the DEI office is working on identifying businesses to spotlight in these videos.
  - Newcomers Academy. Ernestor shared that the DEI office is currently planning a Newcomers Academy. This will be an 8-week pilot program that will start this summer to welcome Ukrainian refugees in the community.

• Citizenship Legal Clinic. Ernestor discussed hosting two sessions with Q&As about becoming a citizen instead of a citizenship legal clinic. One of the sessions will be specific to Ukrainian refugees in the community.
