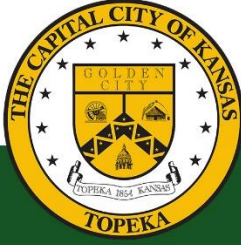

Call to Order. Chair Romero-Nichols called the meeting to order at 5:31 pm.

Roll Call. Present: Chair Carmen Romero-Nichols; Commissioner Luc Bensimon; Commissioner Marisol Marcelo; Commissioner Roberts; Commissioner Alexis Simmons; and Commissioner Zachary Surritt. Absent: Commissioner Cynthia Hopp and Commissioner Pamela James

Guests. Ernestor De La Rosa, Chief Diversity Equity and Inclusion Officer; Zaynah Afada, Diversity Equity and Inclusion Program Coordinator; and Kaitlyn Willis, Executive Assistant to the City Manager.

Adoption of December 11, 2023 Minutes and January 8, 2024 Agenda. Commissioner Surritt moved and Commissioner Marcelo seconded a motion to amend the minutes to reflect that Chair Romero-Nichols was elected to be Chair. Chair Romero-Nichols moved and Chair Roberts seconded a motion to adopt the minutes as amended and the agenda as written. Motion passed unanimously.

Old Business.

- **Election of Vice Chair.** A Zoom poll was conducted asking Commissioners to vote for either Commissioner Bensimon or Commissioner Roberts to serve as Vice Chair. The results of the poll were displayed and showed that Commissioner Roberts was selected. Chair Romero-Nichols asked for a vote to approve this selection, and the Commission voted unanimously to elect Commissioner Roberts to serve as Vice Chair.
- **2023 HRC Annual Report.** Ernestor shared that he and Zaynah are continuing to edit the report.
- **NLC Diversity Entrepreneurship Program.** Ernestor shared that he has been meeting with community partners and discussed a potential grant that we can apply for to help implement this program.
- **AARP Presentation - Age Friendly Initiative.** Zaynah shared that she is working on the application and it should be submitted before the next meeting.

Other Announcements.

- **Taste of Topeka.** Ernestor stated that the Event Planning Subcommittee will be meeting this month to discuss this event.
- **MEI.** Ernestor discussed the LGBTQ Liaison position with the Police Department.
