Subject: Downtown Parking Proposed Changes

The proposals discussed in the September 14th Public Works Infrastructure Committee (PWI) were discussed with the Downtown Topeka Inc. Board and Parking Committees over the past month. DTI is endorsing the plan, and we recommend PWI approves.

Included:

- Removal of Temporary Yellow Hooding: Restore 2-hour metered parking on the 100 blocks directly East and West of Kansas Ave.
- Simplifying the Parking Zones: Reduce downtown visitor confusion
- Test App Only Payment Zones: Read the adoption rate to understand future potential onstreet infrastructure needs
- Adjust Munciple Code, Chapter 10.60, Parking Rate and Fee Structures: Implement Min/Max pricing structure enabling demand-based pricing model

In support of the proposed parking changes, the City Parking Division has begun efforts to align with the recommendations and request support in the proposed changes to the Municipal Code regarding parking rate and fee structures.

Removal of Temporary Yellow Hooding


The recommendation will be presented to the Governing Body at the Council meeting on October 12th with the support of DTI.

Simplifying the Parking Zones

The City Parking Division is currently undertaking an inventory of the replacement meters to simplify parking zone efforts. Some of the proposed changes will require meters to be rekeyed. That will increase the level of effort and time for the deployment of the meters.

Test App Only Payment Zones

City Parking Staff has requested feedback from downtown stakeholders to evaluate the pilot area for this test.
