



Commissioner Vicki Arnett Proposal Plan C Map






#### Proposed Public Input Process (for discussion)

Written Comments. Written comments can be submitted via email to <a href="mailto:cclerk@topeka.org">cclerk@topeka.org</a>. Comments may also be delivered in-person or mailed to the Office of the City Clerk located at 215 SE 8th Street, Room 166, Topeka, Kansas, 66603. All written comments will be distributed to Commission members.

**In-Person Comments.** In-person comments will be considered at the public hearing on Thursday, August 18 at 5 p.m. at the Holliday Building. Individuals may appear in person or by Zoom. If appearing by Zoom, the individual must notify the City Clerk by 4 p.m. on August 18 so that communications staff can be notified to provide the Zoom link.

Comments shall be limited to 4 minutes.

Each person shall step up to the microphone and shall state his or her name for the record.

All remarks shall be addressed to the Commission as a whole and not to any individual member.
