NIA SUPPORT FUND PROGRAM BUDGET & ACTIVITY CHANGES

Explanation Summary

On May 8, 2024, HUD Announced a decrease in Grant funds of \$114,348 for the City of Topeka. This is the largest cut we have experienced in the last 10 years of HUD grant funding. The total amount for Service-Based Activities cannot exceed 15% of the CDBG Grant amount, meaning that Service-Based activities will need to be reduced to maintain this cap based on the new grant total amount. Due to this grant reduction, NIA Support funding has been reduced to \$35,000 from CDBG for 2024. The City of Topeka Finance Department has determined that the City's General Fund can compensate this reduction by providing \$15,000 for NIA Support through the remainder of 2024. This brings the total NIA Support Fund Budget for 2024 to \$50,000.
