Animals will need to be up-to-date on their vaccines prior to scheduling a surgery appointment.

## City of Topeka to donate 1,200 desktop computers to qualifying residents

TOPEKA, Kan. – The City of Topeka's new digital equity program, TSC – Get Digital, is giving out 1,200 desktop computers to qualifying applicants.

The desktop computers are available for 60 and older residents living within the City of Topeka city limits. To qualify, residents must receive SNAP, Medicaid, SSI, Federal Public Housing Assistance, Veterans Pension Benefit Program, or have a household income that is less than 200% of federal poverty guidelines on an annual basis.

"As we are living longer, our world is becoming increasingly digital. Information and communication can enable healthy and active aging by facilitating access to information, health and healthcare, socio-economic participation and other factors that promote full engagement and participation as we age," said Monique Glaude', Director of Community Engagement and Ombudsman for the City of Topeka. "Although many older adults are frequent users of information and communication technologies, many still lack access, and the pace of digital innovation is yet to be inclusive of their needs. We are appreciative of the donation from the Jayhawk Area Agency on Aging which will assist us in providing desktop computers to 1,200 of our 60 and older low-to-moderate income neighbors."

The funding for the computers was made possible thanks to a \$140,000 donation from the Jayhawk Area Agency on Aging (JAAA).

"Jayhawk Area Agency on Aging is pleased to be a part of the TSC – Get Digital Coalition and able to help support the efforts of Get Digital and extremely pleased that we will be able to assist such a large number of older adults gain access to technology that will enhance their lives in many ways from helping them stay connected socially with friends and family, to allowing for telemedicine visits, and much more," said Susan Harris, Executive Director, Jayhawk Area Agency on Aging.

## Are you over the age of 60? If so, you may qualify for a **FREE desktop computer!**

### Who is Eligible?

If you are 60 or older and reside in the City of Topeka city limits and receive SNAP, Medicaid, SSI, Federal Public Housing Assistance, Veterans Pension Benefit Program or have a household income that is less than 200% of federal poverty guidelines (see table to the right) per year, contact us 785-368-3098 to see if you qualify for a FREE desktop computer.

### Qualifying Income-Based Assistance Programs

Documents must be dated within the last year and/or show current coverage at the date of submission.

- Adult and Child Mental Health Case Management
- Employment Services (Only if income-based in your state)
- Extended Foster Care
- Food Support (A dated letter showing current eligibility is required)
- Financial Assistance, such as GA, TANF, etc. (A Dated letter showing current eligibility is required)
- Head Start (LIHEAP)
- Medicaid or Medical Assistance (Bring a document that says "MA" or "Medical Assistance" on it)
- The National School Lunch Program's Free or Reduced Lunch Program
- Section 8, Federal Public Housing Assistance, or Group Residential Housing (GRH)
- Social Security Disability (SSD)
- Supplemental Security Income (SSI)
- Federal Pell Grant

### Qualifying Income Documentation

For households that qualify under the Net Income Test (200% Federal Poverty Level FPL) the following documentation will be acceptable as part of the application process. Annual benefits must meet the FPL guidelines (see table to the right):

- The prior year's state, federal or tribal tax return (W-2's forms, or pay stubs are not acceptable)
- A Social Security statement of benefits
- A Veterans Administration statement of benefits (VA cards alone are not accepted)
- A retirement/pension statement of benefits
- An Unemployment/Workman's Compensation statement of benefits
- Federal or tribal notice letter of participation in General Assistance

### Eligibility

TSC - Get Digital (City of Topeka) requires photo identification and income documentation for program qualification. Acceptable documents for income documentation fall into 2 categories: 1) proof of current enrollment in an income-based government assistance program OR 2) documentation from a government source of current income under 200% of the federal poverty level (relative to household size). Please note we do not check citizenship or immigration status.

### Acceptable Forms of Photo Identification

- Driver's License or state ID card for non-drivers
- Passport
- Formal ID card (such as Veterans or student)
- Company or work-issued identification

### Household Income Guidelines

1 - \$25,760 • 2 - \$34,840 • 3 - \$43,920 • 4 - \$53,300  
5 - \$62,080 • 6 - \$71,160 • 7 - \$78,240 • 8 - \$89,320  
Each additional person add \$9,080

### The Following Documents WILL NOT Be Accepted

- Hand-written documents
- Tax returns where the applicant is claimed as a dependent
- Medicare
- W-2 forms or paystubs
- Bank statements with deposit records
- EBT app screenshots
- Notices to reapply for a benefit

*\*Any proof of eligibility is subject to approval by the City of Topeka. Additional documents may be required to unquestionably prove income or enrollment in a government assistance program.*

Just a few minutes away from downtown Kansas City, campers will find a traditional, overnight summer camp experience, nestled in the trees of a suburban neighborhood. Campers will enjoy a ropes course, hiking, archery, gaga ball, pool, and a host of other activities during their time at camp, while parents will have the peace of mind of sending their children to a safe environment to meet and build relationships with other kids their age:

Kids need camp more than ever," said Carrie Dixon, Three Trails Marketing and Guest Relations Director. "At Three Trails Camp, we are uniquely positioned to help kids from all social-economic statuses heal from the experiences of the last year and just be a kid again."

The [Kansas Homeowner Assistance Fund \(KHAF\)](#) program is open for applications! Don't wait, apply today! Funds are limited.

The program's goal is to aid homeowners in avoiding foreclosure by assisting with homeownership related expenses.

**Applicants must be at least 30 days past due on their mortgage or property taxes/charges to qualify for assistance types.**

### Qualifications

- The household gross income must not be more than 150 percent (150%) of the area median income (AMI) for the County in which the property is located or 100% US Median Income. See [KHAF Income Chart](#).
- The property must be located within the state of Kansas.
- The property must be the applicant's primary residence.
- The applicant must be the owner of the property.
- Applicants must be at least 30 days past due on their mortgage or property taxes/charges to qualify for assistance types.
- There must be a pandemic-related financial hardship after January 21, 2021 (loss of income or increase in expenses).
- Original mortgage amount must be within [conforming loan limits](#).

### Eligible Properties

- Owner Occupied, Primary Residences (second homes and investment properties are not eligible for assistance).
- Single Family Residences, One to Four Unit Dwellings, Condos, Manufactured Homes (affixed and unaffixed) and Townhomes.

### Assistance Terms

- \$45,000 Max Assistance Amount (this is a combination of up to \$35,000 in mortgage reinstatement and payment assistance plus up to \$10,000 in property charges and utility/internet/broadband assistance) provided as a grant up to \$25,000 and a two-year forgivable loan for mortgage related assistance more than \$25,000.

## Assistance Types

### **Mortgage Reinstatement Assistance**

- Mortgage must be past due by at least 30 days.
- Assistance up to \$35,000.
- Reinstatement assistance must bring the mortgage current by curing all past-due amounts.
- This assistance covers **past due primary mortgage, second mortgages, reverse mortgages, and even non-traditional loans such as land contracts (contract for deed) or manufactured homes.**

### **Mortgage Payment Assistance**

- Must have current mortgage delinquency.
- Combined assistance (including reinstatement) up to \$35,000.
- Up to six (6) months of forward payment assistance paid directly to mortgage servicer.

### **Property Charges Assistance**

- Property charges and/or taxes must be past due by at least 30 days.
- Assistance up to \$10,000 maximum (inclusive of utility/internet/broadband assistance when applicable).
- This assistance covers **past due** property charges including property taxes, insurance premiums (including homeowner's insurance and flood insurance), homeowner association fees, condominium association fees, cooperative maintenance, and common charges.

### **Utility/Internet/Broadband Assistance**

- Must have mortgage or property tax/charge delinquency to qualify.
- Assistance up to \$10,000 maximum (inclusive of property charges assistance when applicable).
- This assistance covers **past due** electricity, water, wastewater, gas, home energy, internet, and broadband.

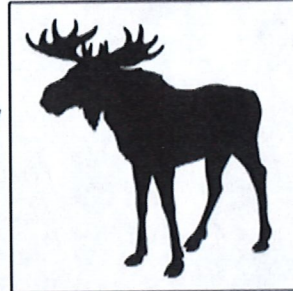

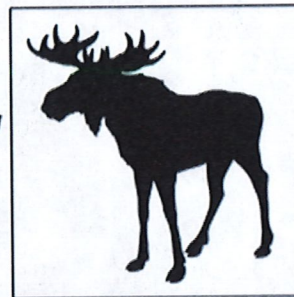

**Starting Monday, May 16<sup>th</sup>**, KGE Construction will be **closing the right eastbound lane of SW 8<sup>th</sup> St between SW Jackson and S Kansas Ave** for repairs to the adjacent sidewalk. The **project will last approximately 1 week**, but will only be active from 7:00 AM thru 5:00 PM, after which traffic control will be moved aside to allow both eastbound lanes open.



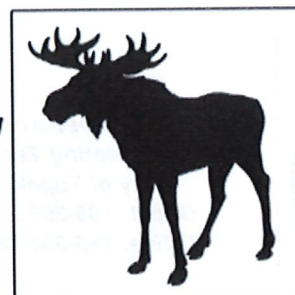

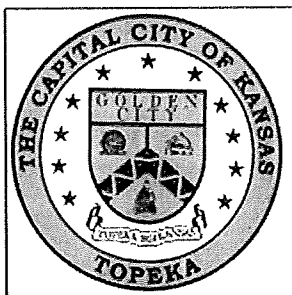
