






Personal and Professional classes are available monthly, but services are available to anyone year-round!





SPECIAL ASSISTANCE in FIRE EMERGENCIES (SAFE) PROGRAM

This Program is designed to identify citizens who require special assistance in the event of an emergency incident. The program is not designed to replace a comprehensive home fire escape plan, but to provide information to our responding units that there is the potential for someone to be delayed or have issues while trying to self-evacuate during an emergency from a private residence.

WHO COULD BENEFIT FROM THIS PROGRAM?

- Senior citizens with mobility issues (Not intended for individuals living in assisted living facilities or nursing homes)
- People with vision, hearing or other impairments
- People confined to a bed, use a wheelchair or have other physical disabilities
- Anyone who feels that in the event of an emergency, self-evacuation would be difficult or delayed

HOW DO WE INTEND TO IDENTIFY THOSE WHO NEED OUR HELP?

You will be required to give some basic information regarding the type of special assistance that may be needed. Once we have reviewed the application, you will be contacted by the Topeka Fire Department.

HOW WILL RESPONDING COMPANIES KNOW YOU NEED ASSISTANCE?

When all your information is gathered and processed, it will be added to the 911 dispatch center database. This information will then be relayed to responding Topeka Fire Department personnel in the event of an emergency incident.

- ➡ A 911 call is initiated
- ➡ The Topeka Fire Department is notified and responds to the call
- ➡ The dispatcher will be alerted that the address is flagged as a SAFE address
- ➡ Specific information gathered during the registration process will be relayed to the responding emergency personnel
- ➡ When emergency personnel arrive, they will have additional information to better mitigate the emergency situation

All participants in the SAFE program will be required to register annually.

Fire won't wait. Plan your escape.





Topeka Police arrest railroad burglary suspect

TOPEKA, Kan. – On February 28, 2024, around 1:15 a.m., officers from the Topeka Police Department (TPD) responded to reported suspicious persons in the 1800 block of NW Brickyard Rd. Upon arrival, officers did not find that a crime had been committed but noticed a vehicle near the railroad tracks. Upon further investigation, officers determined one of the rail cars had open doors and there was wire on the ground.

An individual emerged from the rail car, identified later as Matthew G. Allender, 41, of Topeka, and attempted to flee. Officers then took him into custody. The Union Pacific Railroad was contacted and it was determined there was around \$550,000 in damage to the rail cars that had been burglarized.

As a result of the investigation, Allender was arrested and booked into the Shawnee County Department of Corrections on the following charges:

Burglary; Vehicle to commit felony, theft, DV, or sexually motivated crime
Felony theft \$25,000 < \$100,000 Motor Vehicle Parts or Accessories
Criminal damage to property; Felony
Interference with LEO; knowingly flee by means other than motor vehicle for felony cases
Criminal trespass; Property as posted per KSA 32-1013
