407 SW Tyler St.

TOPEKA, Kan. – On March 17, 2024, just before 5:30 a.m., crews from the Topeka Fire Department (TFD) responded to a two-story house fire at 407 SW Tyler St. Upon arrival, crews found heavy smoke and flames coming from the structure and began attacking the fire, keeping it contained to the original structure. All occupants had evacuated prior to TFD's arrival and no injuries were reported.

A TFD Investigation Unit responded to determine the cause and origin of the fire. The following is a brief summary:

- The cause of the fire remains undetermined; still under investigation.
- The total estimated loss from the fire was approximately \$120,000 with \$110,000 in structural loss and \$10,000 in content loss.
- TFD response included 4 Engine Companies, 2 Truck Companies, 1 Aerial Company and 2 Battalion Chiefs.
- Assisting agencies included American Medical Response, American Red Cross, Evergy, the Kansas Gas Service and the Topeka Police Department.
- Smoke detectors were not located in the house where the fire originated.

- Assisting agencies included American Medical Response, the American Red Cross, Evergy, the Kansas Gas Service, the Kansas State Fire Marshal's Office and the Topeka Police Department.
- Smoke detectors were not located in the house where the fire originated.
