TOPEKA DREAMS NEIGHBORHOOD IMPROVEMENT INITIATIVES PROGRAM (NIIP)

The Topeka DREAMS Neighborhood Improvement Initiatives Program (NIIP) is a neighborhood investment partnership program between the City of Topeka and area Neighborhood Improvement Associations (NIAs). The program is designed to assist NIAs with improving their neighborhoods through, community collaboration, neighborhood planning, public infrastructure improvements, and housing rehabilitation and potential affordable housing in low and moderate-income (LMI) neighborhoods of Topeka. This partnership allows for the planning, design, and completion of projects that address current conditions, and the identification of goals for future neighborhood infrastructure, housing, and other quality of life improvements. The City works to implement the priority projects, identified by the community, into the City of Topeka's Capital Improvement Plan, Capital Improvement Budget, and annual Housing and Urban Development (HUD) Community Development Block (CDBG) Funding priorities for neighborhood projects through three initiative levels.

DREAMS 1 - BIENNIAL NEIGHBORHOOD INVESTMENT PROGRAM

1 NIA Neighborhood Awarded Biennially

As part of the Neighborhood Improvement Initiatives Program (NIIP) the City of Topeka invest in one Intensive Care or At-Risk neighborhood (restricted to those with At-Risk block groups in danger of becoming Intensive Care (health scores = 2.0 or lower from latest health update) * biennially.

- Development of a Comprehensive Neighborhood Plan (outlining current neighborhood conditions, future goals, future land use map, and neighborhood-specific elements (e.g., Infrastructure, housing, and other quality of life improvements)
- Up to \$1.4 million of the City of Topeka's Capital Improvement Funding
- Up to \$150,000 of Utilities funding for public infrastructure improvements
- Up to \$330,000 in HUD funding for housing rehabilitation and *potential affordable housing.

Note: The DREAMS 1 Awardee will not be eligible to receive DREAMS 2 or DREAMS 3 project grants during the current award year and must wait for at least one funding cycle after being awarded to re-apply.

Note: all individual Housing Rehab property owner applicants are subject to Housing and Urban Development and City of Topeka Housing Services requirements for eligibility and approval (<u>Link to Housing Services Here</u>).

(NIAs Applying for DREAMS 1 may also opt to be considered for DREAMS 2 Housing if their NIA is not selected for DREAMS 1)

OTHER PROGRAM CONDITIONS

- 1. Funding priority for projects will be given to infrastructure projects identified in the target area and no more than 5% of the total infrastructure budget will be spent on public parks.
- 2. Funding for ALL NON-CITY public amenities require at least 50% matching funds and should constitute no more than 5% of the overall infrastructure budget. The 50% matching funds may be financed through other sources such as community groups (associations), public and private entities, non-profits, and other government entities.

DREAMS 2 – BIENNIAL NEIGHBORHOOD HOUSING REHAB PROGRAM

Up to Four NIA Neighborhood's Awarded Biennially

(NIAs Applying for DREAMS 1 may also opt to be considered for DREAMS 2 Housing if their NIA is not selected for DREAMS 1)

As part of the Neighborhood Improvement Initiatives Program (NIIP), up to \$330,000 in HUD housing rehabilitation funding may be divided amongst up to four NIA neighborhoods.

- Major Home Rehab Up to \$30,000 awarded to individual income-eligible homeowners on a first on a first-come-first-serve basis in the selected neighborhoods.
- Minor Housing Rehab Up to \$15,000 awarded to individual property owners (landlords) on a first on a first-come-first-serve basis in the selected neighborhoods.
- Voluntary Demolition and Infill housing may also be an option

DREAMS 2 – BIENNIAL MAJOR NEIGHBORHOOD IMPROVEMENTS PROGRAM

Multiple NIA Neighborhood Projects Awarded Biennially

As part of the Neighborhood Improvement Initiatives Program (NIIP)

- 1. Up to \$1.4 million (between \$100,000 up to \$1,000,000 per project) of the City of Topeka's Capital Improvement Funding, and \$150,000 of Utilities sanitary sewer funding for public infrastructure improvements will be awarded for multiple NIA neighborhood projects biennially.
- 2. Funding may also be used as local match funding for larger public infrastructure improvements.
- 3. NIAs may also collaborate with Interested community partners to apply for grant funding for public infrastructure improvements.

PROGRAM CONDITIONS

- 4. Funding priority for projects will be given to infrastructure projects and no more than 5% of the total infrastructure budget will be spent on public parks.
- 5. Funding for ALL NON-CITY public amenities require at least 50% matching funds and should constitute no more than 5% of the overall infrastructure budget. The 50% matching funds may be financed through other sources such as community groups (associations), public and private entities, non-profits, and other government entities.

DREAMS 3 – ANNUAL MINI-GRANTS PROGRAM

Multiple NIA Neighborhood Projects Awarded Annually

DREAMS 3 is funded through the federal Community Development Block Grant (CDBG) Program and from the City's General Obligation (GO) Bonds. These funds are used to support a variety of small neighborhood-based public projects or local match funds for larger public initiatives. Projects must be located within predominately low/moderate-income (LMI) neighborhoods. Program priorities include community public service activities for LMI persons, infrastructure improvements, neighborhood beautification, and quality of life enrichment.

- \$60,000 CDBG funding
- \$140,000 (GO) Bonds funding
- Grant awards range from \$1,000 up to \$50,000
- NIAs may also collaborate with Interested community partners to apply for grant funding for public improvements and services.

- Internal COT Review Committee: comprised of city employees and the selected CAC Review Committee (3 members). All applications will be reviewed by the internal review committee for further recommendations and approvals. Applications will be reviewed on the basis of meeting federal, state and local regulations, standards and requirements. Neighborhoods will have an opportunity to update applications if needed.

September 27, 2024 COT Review Committee Recommendations provided to applying NIAs **October 11, 2024** Final DREAMS Applications Due (Only revised applications)

POST APPLICATION

October 19, 2024 CAC Review Committee Workshop (Saturday event)- the CAC will review applications and the recommendations of the Internal COT Review Committee and score applications in order of funding priority.

October 31, 2024 CAC Scoring forms due to Community Engagement

November 6, 2024 CAC vote to approve priority funding recommendations based on scoring outcomes.

November 19, 2024 Community Engagement present recommendations to City Council (CAC Chair & Vice Chair attend) **December 3, 2024** City Council approves final recommendations
