I want to speak about the group despite COVID challenges they set goals and I see them doing great things in the future.

## • David Bawden – Oakland NIA

It took two and half years to get a LULAC a grant from ArtsConnect for a mural. The dedication was a big celebration in Oakland. I also want to thank LaToya for her help.

## • Debby DuBois – Historic Old Town NIA

We were able to form partnerships and collaboration with Stormont Vail and Grace Episcopal Cathedral. The Church is starting a garden and we will be working with them on this project.
