Introduction: This report analyzes and compares demographic information found in the 2020 Census for demographics of population, household, and housing unit counts in and around Topeka by using information from the 1990, 2000, 2010, and 2020 Decennial Censuses and American Community Survey (2016-2020) five year dataset, which should be useful for government, business, and the general public. The 2020 Decennial Census did not include specific demographic information, and the fiver-year American Community Survey (ACS) dataset was used to complement the 2020 Decennial Census.

The first section of this report - "How We Compare?" - presents a snapshot of Topeka in comparison to several selected Kansas Cities. Lawrence, Manhattan, Olathe, Overland Park, Wichita, and Wyandotte County were selected because they are the primary population centers in Kansas and useful for comparison purposes to Topeka. Select comparisons are also made with the State of Kansas and the United States.

Population Highlights:

- Total Population within incorporated Topeka has grown by 5.6% since 1990, from 119,866 to 126,587 in 2020. Over this time, Topeka has experienced a slowing population growth, with 1990 to 2000 seeing a growth of 2.1%, 2000 to 2010 seeing a 4.2% growth, and 2010 to 2020 experiencing a contraction in population of -0.7%. Overall, Topeka has experienced an annual growth rate of 0.19 since 1990. *Page 4*
- The City of Topeka continues to see a decline in its share of population, as a percent of Shawnee County. However, this trend has slowed since 2000, with a share loss of 1.2% (72% v 70.8%) over 20 years as opposed to a 10.1% share loss from 1960 to 1990 (84.6% v 74.5%. *Page 5*
- The fastest growing age cohort within the City of Topeka was the 65+ age cohort, which grew by 25.5% from 2010 to 2020. All other cohorts, 0-4 (preschool), 5-19 (school age), and 2-64 (workforce), saw a decrease. *Page 6*
- Several demographic groups grew within the City of Topeka. Specifically, those identifying as two or more races (139%), Hispanic or Latino (22%), Asian alone (21%), and some other race alone (65%). The White, Black, and American Indian and Alaska Native alone demographic groups all experienced a decrease in population. While some of these changes may be due to the large increase in the population of two or more races, this does not account for the total population loses in those demographic groups. *Page 7*

Household Highlights:

- The average household size in the City of Topeka decreased to 2.24 from 2.29 in 2020. Household size has been in decline since 1990 when it was 2.39. Page 9
- 35.8% of all Topeka's family households with children under 18 were headed by one parent. This is a larger percent than the State (29.2%) and the U.S. (31.7%). Wichita (37.4%) and Wyandotte County (41.2%) were the only peers with a greater percent. *Page 9*

Housing Highlights:

- Homeownership rates remained nearly identical from 2010 to 2020 with owner occupancy raising from 58.3% to 58.6%. Page 10
- Housing unit counts show that while the total housing units increased by 0.8%, it was at a much slower pace than previous decades (5.3% from 2000 to 2010 and 3.2% from 1990 to 2000). From 2010 to 2020, nearly the same number of units were vacant as were added to the housing inventory. *Page 10*

Poverty and Income Highlights:

- From 2010 to 2020 the percent of persons in poverty dropped in Topeka from 18.8% to 13.9%. Page 12
- 2020 data shows Topeka being roughly 2.5 to 2.8 percentage points higher in poverty rate than Shawnee County and the State of Kansas. Page 12
- Per capita income and median household income show Topeka still lags behind peer cities, Shawnee County, and the State of Kansas. Page 11

- The 2020 Census indicates that 40.2% of Kansas's population is located within the major cities of Lawrence, Manhattan, Olathe, Overland Park, Wichita, Topeka, and Wyandotte County. The 2010 Census indicated that 38.4% of the State's population was centered here in these same cities.
- With a total population of 126,587, Topeka is ranked5th in population.
- Topeka comprised 4.5% of the State's total population in 2010 and 4.3% in 2020, showing a slight decline.
- Topeka's Annual Growth Rate from 2010-2020 was -0.1%, which was lower than comparable cities and the state Annual Growth Average.

City/County Share of Population - The percentage of Shawnee County residents living within the City of Topeka corporate limits peaked at 84.6% in 1960, as demonstrated below. Since that time, this percentage has steadily declined. By the 2020 census, the lowest percentage (70.8%) of residents lived **inside** the corporate limits of the City since 1910 (70.6%). Much of this is attributed to the population moving outside of Topeka's core into the fringe areas of the City. It should be noted that the decline in Topeka's share of Shawnee County has been slowing since 2000, with the City Share shrinking by less than one percent per decade since 2000. (See Graphic Below)

Annual Growth Rates - Table 2 below shows historical growth rates in Shawnee County, Topeka, and the balance of Shawnee County. The annual growth rate for the balance of Shawnee County (excluding City of Topeka) was 0.37% from 2010 to 2020, while the annual growth rate for the City of Topeka from 2010 to 2020 was -0.07%. This helps to explain why Topeka's population as a percent of the County's has been steadily declining since 1960 because the unincorporated parts of the County have been growing faster than the City of Topeka's population since 1970. Although incorporated Topeka had been growing faster in recent decades, it was not growing at the same pace as other areas of the County. While the population dropped according to the 2020 Census, the subsequent decades had experienced a doubling of growth rates from the previous decline in 1980.



Age Characteristic of Population

Table 3 shows that only one age cohort within the City of Topeka grew from 2010 to 2020, the 65 and over group, which grew 25.49%. The school age cohort (5 to 19) experienced the smallest decline of 3.93%. The preschool cohort experienced the largest percent decline (14.64%), while having the second largest actual change. The workforce cohort experienced the largest decrease in actual population (-3,919), but makes up the largest segment of Topeka's population and accounted for a 5.23% decrease. Topeka's current age population distribution shows that there are more females than males by total population, but this number exclusively comes from the cohorts of 20 to 64 and 65 & over (Chart 3).

- In 2020, Topeka had a higher proportion of senior citizens (65 & over) than the national, state, and comparable cities proportions. (Chart 2)
- Topeka had the lowest percent of 20 to 64 year olds of comparable cities within Kansas. (Chart 2)
- Topeka has a lower proportion of 5 to 19 and 20 to 64 year olds than the national, state, and comparable cities within Kansas. (Chart 2)




- "White alone" comprised 68.4% of the total population of Topeka, which is higher than the United States (61.6%) and lower than the State of Kansas (75.6%).
- "Black alone" comprised 10.4% of the population of Topeka, which is lower than the United States (12.4%) and higher than the State of Kansas (5.7%).
- Topeka had one of the higher rates of the population classifying themselves as "Two or more races" at (11.9%) of the select comparable cities, Wyandotte County was the only one with a higher percent (14.9%). This was higher than both the State of Kansas (9.5%) and the United States (10.2%).

Definitions:

White – A person having origins in any of the original peoples of Europe, the Middle East, or North Africa.

Black or African American – A person having origins in any of the Black racial groups of Africa.

American Indian or Alaska Native – A person having origins in any of the original peoples of North and South America (including Central America) and who maintains tribal affiliation or community attachment.

Asian – A person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian subcontinent including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam.

Native Hawaiian or Other Pacific Islander – A person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands.



- 18.7% of the total U.S. population is of Hispanic or Latino origin. In the State of Kansas, this percent drops to 13%. In Topeka, this percentage is 16.4% of the total population.
- "White", "Some Other Race Alone", and "Two or More Races" represent 94% of the Hispanic or Latino population in Topeka.
- "White" Hispanic or Latino comprise 4.3% of Topeka's population , as compared to 3.8% nationwide.
- 88.5% of the Hispanic/Latino population in Topeka are of Mexican origin compared to 61.5% in the U.S. and 81.1% in Kansas.

Definitions:

Hispanic/Latino Origin - A person of Cuban, Mexican, Puerto Rican, South/Central American, or other Spanish descent regardless of their race.



- 56.1% of all Topeka households were families compared to 64.6% in Kansas and 65.3% in the U.S.
- Average family and household size were smaller than both Kansas and the U. S.
- 35.8% of all Topeka family households containing children under the age of 18 were headed by a single parent, a decrease of 8.2% since 2010. 26.4% of these families were female head of household only. 29.8% of all Kansas family households containing children were single parent headed, with 20.8% being female lead.

Definitions:

Household - Includes all people who occupy a housing unit. One person is designated the householder or head. All households are either "family" or "non-family".

Family Household - Consists of the household and one or more persons living in the household who are related to the householder by birth, marriage or adoption. May also contain individuals not related to the householder.


Non-family households - Consists of a householder living alone or with nonrelatives only. (i.e. roommate or unmarried partner)


Husband-wife household - the householder and his or her spouse of the opposite sex are members of the same household. "Same sex spousal households" may either be classified "family" or "non-family" depending on the presence of another person related to the householder.

- 10.2% of Topeka housing units were vacant as indicated by the 2020 Census, which is higher rate than our peer cities, state, and national averages. (*Table 7*) This represents an increase of 0.7% from 2010.
- 58.6% of housing units were owner-occupied in 2020, which represents an increase of 0.3% since 2010. Topeka had a lower rate of owner-occupancy than the State and Nation, but was had a similar rate to Wyandotte County and Wichita. (*Chart 5*)




- Topeka's Median Household income grew over \$9,000 since 2010, representing a 23.1% increase. This is consistent with the state who experienced a 23.6% change from 2010 and 2% less than the national increase of 25.2%. *Table 8*; *Page 11*
- While Topeka experienced nearly a \$5,000 increase in the per capita income, this represented only a 20.8% growth from 2010, which was the smallest increase compared to national, state, and peer cities. Table 9; Page 11
- 13.9% of Topeka's sampled population were classified as being below the poverty income threshold, as compared to 18.8% in 2010. Compared to the State (11.4%) and Nation (12.8%) Topeka has a higher rate of persons below poverty, but is below several peer cities. *Table 10*



- Of Topeka's population aged 25+, 32.5% obtained a high school diploma or GED, which is high than the State (25.8%) and National (26.7%) rate.
- 39.4% of Topeka's population aged 18 to 24 had obtained a high school diploma or GED, which is also higher than the State (29.7%) and National (32.1%) rate.
- Of the total population in Topeka, 31.2% had obtained some college or an Associate's degree. This is lower than the State (38.9%) rate, but higher than the National (30.7%).
- Of the total population in Topeka, 17.6% had obtained a Bachelor's degree. This is lower than the State (23.2%) and National (19.2%) rate.
- Of the total population in Topeka, 8.7% had obtained a graduate or professional degree. This is lower than the State (12.5%) and Nation (11.2%).



- 90.5% of those sampled in Topeka reported they drove to work (80.2% drove alone and 10.3% carpooled with at least one other person in the car). nationally, 83.8% reported they drove to work (74.9% drove alone and 8.9 carpooled).
- Nationally, 4.6% reported the used public transit and 3.1% walked or biked. In Topeka, this rate was 1.5% for public transportation and 2.4% for walking or biking to work.
- Those reporting they bicycled to work were less than half a percent in Topeka and statewide. The one exception is Lawrence, which had 1.3% report they bicycled to work.
- In Topeka, 4.7% reported working from home. This was less than statewide (6.4%) and nationally (7.3%).

- 69.6% of residents in Topeka take between 5 to 19 minutes to travel to work one-way, which is a higher percent than the Nation (37.9%) and the State (51.7%).
- For travel times greater than 20 minutes to work, only those traveling 60 plus minutes were at the same level or greater than the peer cities. This is likely due to the residents who travel to the Kansas City metro area for work.





- The female population makes up nearly 51.6% of the total labor force in Topeka. This is slightly higher than the national and state level which are 50.2% and 49.4%.
- Civilian unemployment is 4.9% across all age groups in Topeka. This falls between the national rate of 5.4% and the statewide rate of 4.1%. Of the peer cities only Wyandotte County (6.3%) and Wichita (5.6%)had higher rates of unemployment.
- Three notable age groups stood out in Topeka's unemployment rate. Age groups of 30 to 34, 45 to 54, and 55 to 59 all had unemployment rates higher than the nation, state, and all peer cities. These age groups all fall within the 20 to 64 age group identified on page 6, which indicated the largest loss of true value of Topeka's population.
