"BREACH OF TRUST" NONCRIMINAL REPORTS.

HISTORICALLY "BOT" REPORTS
WERE NON-CRIMINAL INCIDENT
REPORTS USED TO DOCUMENT
WHEN A VERBAL OR SOMETIMES
WRITTEN CIVIL AGREEMENT WAS
"VIOLATED" BY ONE PARTY.

IN AN EFFORT TO BETTER UTILIZE PERSONNEL AND RESOURCES, TPD WILL TAKE CRIMINAL REPORTS FOR THESE MATTERS, ONLY WHEN APPROPRIATE STATE OR LOCAL LEGISLATIVE CRITERIA HAS BEEN MET.

## WHEN CAN I FILE A POLICE REPORT

#### **IMMEDIATELY**

- IF CUSTOMER USES FALSE INFORMATION
- IF CUSTOMER OBTAINS CONTROL
   OF PROPERTY OR VEHICLE BY
   FORCE
- IF CUSTOMER SUBSTANTIALLY
   DAMAGES OR ALTERS PROPERTY
   OR VEHICLE
- IF CUSTOMER FAILS TO RETURN A
   VEHICLE BY AGREED UPON DATE
   AND THE CUSTOMER SIGNED A
   WRITTEN AGREEMENT SPECIFYING
   A TIME AND PLACE TO RETURN THE
   VEHICLE AND THAT AGREEMENT
   STATED THAT FAILURE TO COMPLY
   MAY BE PROSECUTED AS THEFT.

#### (3) DAYS AFTER

 CUSTOMER FAILS TO RETURN A VEHICLE UPON OFFICIAL NOTICE GIVEN

#### (10) DAYS AFTER

 CUSTOMER FAILS TO RETURN PROPERTY ON AGREED UPON DATE

THE STATUTE IS SPECIFIC ABOUT WHEN YOU MAY FILE A CRIMINAL REPORT

THIS ELIMINATES THE NEED FOR YOU TO CONTACT THE POLICE DEPARTMENT MULTIPLE TIMES TO GET THE CASE NUMBER YOU REQUIRE

## THERE WILL BE CONSISTENCY IN REPORTING

 CRIMINAL REPORTS WILL ONLY BE TAKEN ONCE AND THEN THEY WILL BE SENT TO THE INVESTIGATIONS UNIT FOR REVIEW
