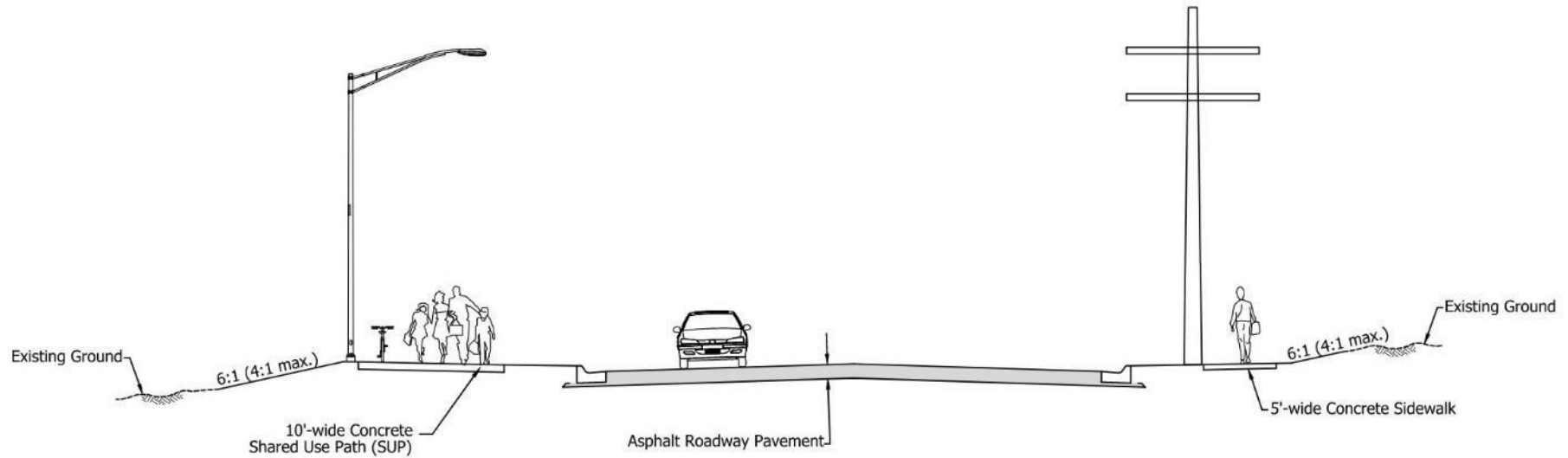

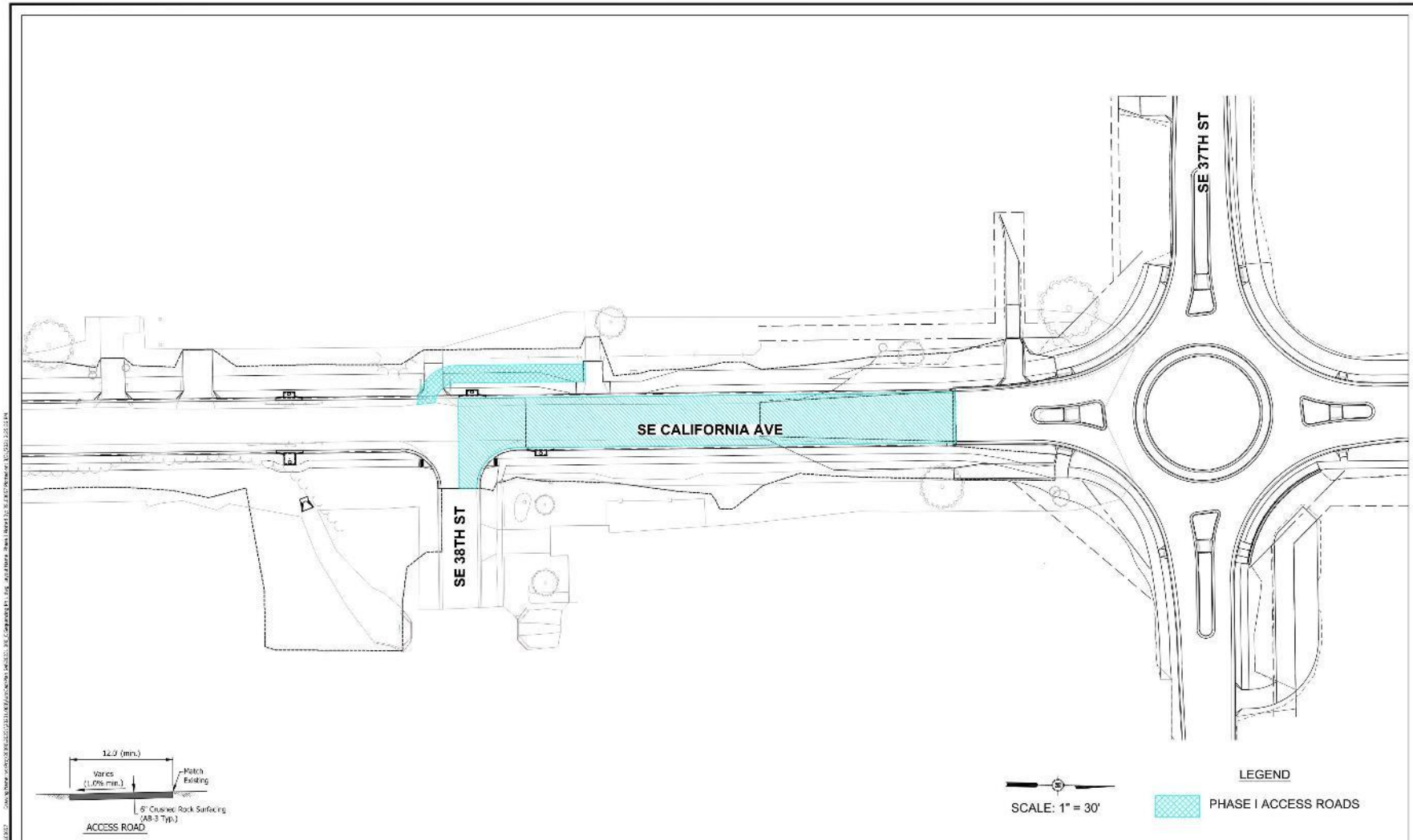
Typical Section

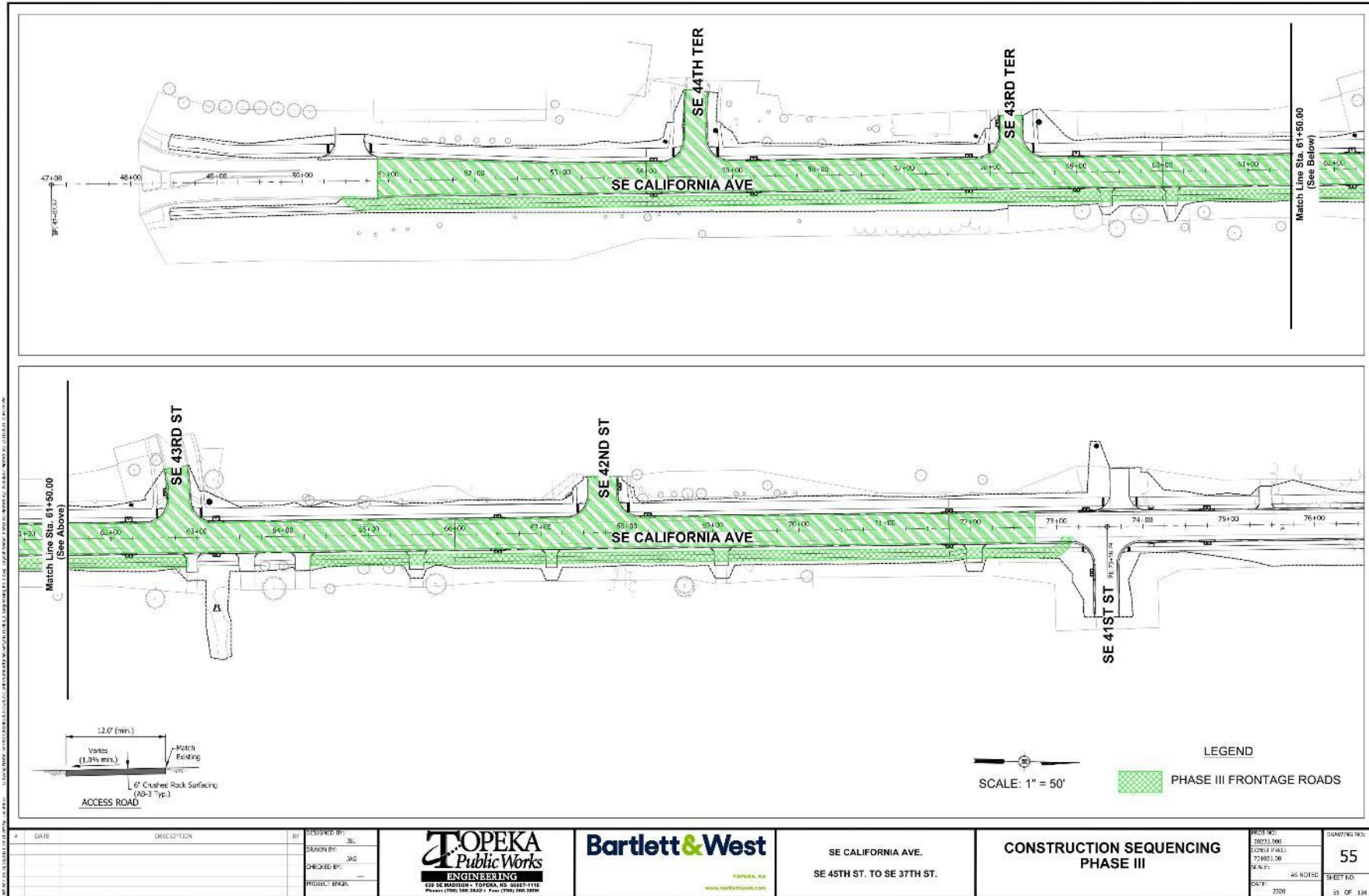
